

**“KARRINYUP – PLAY PASS”**  
**TERMS AND CONDITIONS**

1. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promoter is GPT Management Holdings Limited ABN 67 113 510 188, 631 Level 52 MLC Centre, 19-29 Martin Place, Sydney, NSW 2000 Australia. (“**Promoter**”).
3. This promotion will be conducted at Karrinyup Shopping Centre, 200 Karrinyup Road, Karrinyup WA 60018 (“**Centre**”).
4. A *PLAY PASS* will be available for purchase from Monday 6 January 2025 until Monday 22 February 2025 (the “**Purchasing Period**”) or while stocks last.
5. A *PLAY PASS* can be collected at Karrinyup Shopping Centre from 9AM Saturday 11 January 2025 to 5PM Monday 23 February 2025 (the “**Promotion Period**”).
6. Participating Retailers (“**Participating Retailers**”) include Archie Brothers Cirque Electriq, Holey Moley, HOYTS Cinemas, Play Dates Kids Café, Arirang Korean BBQ, Crinitis, Chatime, Grill’d, Little Laika, Miss Maud, Potato Corner, Roll’d, San Churro, Thaitan Thai Cuisine, Thuggs Fried Chicken, Yana Lane & Chaffic at Karrinyup Shopping Centre only.
7. If, for any reason, the Purchaser does not redeem or use their *PLAY PASS* during the specified Promotion Period, the *PLAY PASS* will be deemed invalid and cash or other prizes will not be offered in replacement.
8. You must be over 18 years of age to purchase or collect a *PLAY PASS*.
9. A *PLAY PASS* is valid to be redeemed for the offers outlined in clause 20 only by individuals aged 5 – 15 years.
10. The Promoter has the right to request a proof of age identification to verify the age of the Purchaser, such as a valid and current WA Driver’s License, Passport or Age Card.
11. Participating Retailers have the right to request proof of age identification to verify the age of the a person redeeming an offer, such as a Passport, School Card or Age Card.

  - b) Once the Humanitix *PLAY PASS* page loads, select ‘Buy Tickets’
  - c) Select the number of *PLAY PASS* they wish to purchase
  - d) Complete the relevant fields including contact details, user details and credit card information.
  - e) Present the confirmation email and QR code to Concierge from to collect their *PLAY PASS*.
  - f) Present their *PLAY PASS* to Participating Retailers to redeem their offer.
13. The total price excludes the Humanitix booking fee and includes GST. All prices and values of the *PLAY PASS* are in Australian Dollars.
14. Should the Purchaser’s contact details change during the Purchasing Period or the Promotion Period, it is the Purchaser’s responsibility to notify the Promoter. A request to access or modify any information provided in an entry must be directed to the Promoter only.
15. Entrants must retain their confirmation email, ticket email and tax invoice(s) from Humanitix as proof of purchase. Failure to produce the proof of purchase for all entries when requested may, in the absolute discretion of the Promoter, result in invalidation of the individuals purchases and forfeiture of any right to their *PLAY PASS*.
16. The Promoter’s decision in relation to any aspect of the *PLAY PASS* is final and binding.

17. **Refunds will not be provided for change of mind.** In the event that a Purchaser is no longer able to attend due to medical or health reasons, the Purchaser will need to contact Karrinyup Shopping Centre and provide relevant documentation. Refunds will be reviewed on a case by case basis.
18. The Promoter reserves the right, at any time, to verify the validity of purchases and the purchaser (including a purchaser's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the purchasing process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper payments of the *PLAY PASS*. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
19. If there is a dispute as to the identity of a purchaser, the Promoter reserves the right, in its sole discretion, to determine the identity of the purchaser.

    - iv. Online bookings available, use code on attached ticket to redeem.

    - i. *PLAY PASS* must be presented to redeem offer.
    - ii. Redeemable for 1 x kids waffle meal, valued at \$12.00.
    - iii. Available daily during store trading hours.
    - iv. Valid at Karrinyup store only.
  - f) **Play Dates – 1 x One Hour Play Pass:**
    - i. *PLAY PASS* must be presented to redeem offer.
    - ii. Redeemable for 1 x 1-hour play pass, valued at \$16.80.
    - iii. Available daily during store trading hours.
    - iv. Valid at Karrinyup store only.
  - g) **San Churro – 1 x Filled Churro and 1 x Kids Milkshake:**
    - i. *PLAY PASS* must be presented to redeem offer.
    - ii. Redeemable for 1 x free filled Churro and 1x Kids Milkshake, valued at \$11.95
    - iii. Available daily during store trading hours.
    - iv. Valid at Karrinyup store only.
  - h) **Valet – 1 x Valet Parking and Hands-Free Shopping Pass:**
    - i. *PLAY PASS* must be presented to redeem offer.
    - ii. Redeemable for 1 x free Valet Parking pass, plus Hands Free shopping, valued at \$15.00.

- iii. Not valid on weekends.

  - iv. Valid at Karrinyup store only.

  - i. *PLAY PASS* must be presented to redeem offer.

  - iv. Valid at Karrinyup store only.

23. *PLAY PASSES* are not transferable or exchangeable and cannot be taken as cash, unless otherwise specified.
24. Purchases are deemed to be received at the time of receipt into the Promoter's database. The Promoter is not responsible for receipt of incorrect, inaccurate or incomplete information either caused by website users or by any of the equipment used, or by any computers or technology used by intermediaries, service providers, or business partners to facilitate the campaign.
25. By purchasing a *PLAY PASS*, Purchasers are providing consent for the Promoter to hold and use their personal information.
26. If for any reason the Promotion cannot be implemented as planned (whether caused by infection by computer virus, line drop out, bugs, tampering, unauthorised intervention, fraud, technical failures or any other cause beyond the control of the Promoter which corrupts or affects the administration, security, fairness or integrity of the offer), the Promoter reserves the right in its sole discretion, (subject to any written direction given by a relevant regulatory authority), to cancel, terminate, modify or suspend the offer. The Promoter may in its sole discretion disqualify any individual who tampers with the purchasing process.
27. Any cost associated with accessing the website/Humanitix page is the Purchasers responsibility and is dependent on the Internet service provider used.
28. Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in WA ("**Non-Excludable Guarantees**"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion.
29. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any purchase that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in ticket value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) taking/use of a ticket.
30. The Promoter collects personal information ("**PI**") in order to conduct the promotion and may, for this purpose, disclose such PI to third parties, including but not limited to agents, contractors, service providers, Participating Retailers and, as required, to Australian regulatory authorities.
